





2018 Park Meadows Mother's Day Giveaway 5/3/2018 - 5/10/18**OFFICIAL RULES**

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. All federal, state and local regulations apply.

1. DATES.

These rules govern the 2018 Park Meadows Mother's Day Giveaway (the "Contest") being conducted by KYGO-FM, KKFN-FM, KOSI-FM (the "Stations"). The Contest will begin at 9:00am Mountain Time ("MT") on May 3, 2018 and will end on May 10, 2018 at 12:00pm MT.

2. ELIGIBILITY

- The Contest is open to all legal U.S. residents (natural persons only) who are 21 years of age or older and who reside in the Denver Metropolitan area (Counties include: Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, Jefferson, Gilpin, Clear Creek, Park and Elbert), except as noted below. Persons ineligible to win include those who do not reside in any of the counties listed above as well as employees, officers, directors, and agents of the Stations, the Stations' licensee, Bonneville International, dba Bonneville Denver, KYGO-FM, KKFN-FM, KOSI-FM, Park Meadows, their parent, subsidiary, and affiliated companies, their advertising or promotional agencies, and any other participating sponsors (collectively, "Promotion Entities"), employees or other persons associated with other radio Stations in the Denver Metropolitan area, and the members of their immediate families and those living in the same household of each (whether related or not) of any of those listed above. "Immediate family" members include spouses, children, step-children, parents, step-parents, siblings and step-siblings. No groups, clubs, or organizations of any kind may participate in this Contest. This Contest is subject to all applicable federal, state and local laws and regulations and is void where prohibited or restricted by law.
- b. Proof of age, identity and eligibility must be furnished to the Stations upon request. All entry information must be complete and accurate. The Stations will not award a prize to anyone not meeting eligibility requirements at the time of
- c. Entrants are required to provide truthful information, and the Stations will reject and delete any entry that it discovers to be false or fraudulent. The Stations will disqualify any entry from individuals who do not meet the eligibility requirements and will also delete any entry as required by law.

3. HOW TO ENTER

a. To participate in the Contest, visit www.kygo.com, www.1043thefan.com, or www.kosi101.com and follow the links and instructions to enter the Contest. Entrants will be asked to answer a poll question as well as submit their first name and last name. zip code, telephone number, date of birth, gender and a valid email address. Only one (1) entry per person per website listed above is permitted. An entrant may have no more than a total of three (3) entries for the entire contest. An entrant may use only one (1) email address for purposes of entry in this Contest. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple entrants are not permitted to share the same email address, and all multiple entries from the same email address shall be disqualified. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by the Stations. Online entry webpage computer is the official time keeping device for the Contest. The Stations are not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties and other technological problems.

b. Entries must be received between May 3, 2018 at 9:00am MT and May 10, 2018 at 11:59am MT ("Entry Period"). Entries submitted outside the Entry Period will be deemed ineligible. Winners may be required to provide valid government-issued photo identification and provide their complete address, date of birth and phone number to claim a prize.

4. PRIZE(S)

- a. There will be one (1) Grand Prize Winner of the Contest. The Grand Prize consists of Dinner for two on Mother's Day weekend from Earls-Park Meadows, a gift basket from The Body Shop, a gift card for a Blow Out at Dry Bar, and chocolate covered strawberries from Godiva. Total Value of Grand Prize: \$300.
- b. The dinner at Earls-Park Meadows will be for Mother's Day weekend only (Friday, May 11, 2018, Saturday, May 12, 2018, or Sunday, May 13, 2018 reservations) via a direct email to Earls-Park Meadows General Manager.
- c. Winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize.
- d. No more than the advertised number of prizes shall be awarded. The prize is subject to certain terms and conditions as specified herein. A prize may not be sold, traded, or commissioned, and is not exchangeable, transferable, substitutable, or redeemable for cash except in Company's sole discretion. Prize details and availability are subject to change. Prizing may be fulfilled by a third party fulfillment company. The prize will only be awarded if properly claimed according to the Rules. 5. WINNER SELECTION, NOTIFICATION AND CLAIM

- a. Decisions of the Stations' management with respect to the Contest are final.
- b. One (1) Grand Prize Qualifier will be selected from all valid entries received from each of the websites listed above at 12:00pm MT on May 10, 2018. There will be a total of three (3) Grand Prize Qualifiers. One (1) Grand Prize Winner will be selected from all Grand Prize Qualifiers at 12:00pm MT on May 10, 2018.
- a. Odds of becoming a Grand Prize Qualifier depend upon the number of valid entries received. Odds of a Grand Prize Qualifier winning the Grand Prize are 1 in 3.

b. The winner must execute and return complete any required affidavit of eligibility and/or liability/publicity release within two (2) weeks of winning or prize will be forfeited. If a potential winner fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, the potential winner forfeits the prize and an alternate winner will not be selected. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by the Stations (or any other commonly owned Stations in the Stations' market) in a calendar year with an aggregate value of \$600 or more. Failure to submit a completed Form W-9 or equivalent upon request will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
