- b. To participate in the Promotion, you may enter online beginning on Tuesday, June 9, 2020 at 9:00 AM MT and ends on Thursday, June 18, 2020 at 10:00 PM MT ("Entry Period").
  - i. Online Entry: To participate visit [www.1043TheFan.com/dad](http://www.1043TheFan.com/dad) between Tuesday, June 9, 2020 at 9:00 AM MT and ends on Thursday, June 18, 2020 at 10:00 PM MT and follow the links and instructions to enter the Contest and complete and submit the online entry form during the Entry Period outlined above. Follow the links and instructions to enter the Contest, and submit a 30 second video about why your dad deserves a credit up to FIVE THOUSAND DOLLARS (\$5,000.00) to ProGreen for the use of installation of artificial turf; and ONE (1) foursome for a round of play at any Aurora Golf Courses, along with your first and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form. Only ONE (1) entry per person is permitted. Any entries over 30 seconds will be disqualified. An entrant may use only ONE (1) email address for purposes of entry in this Contest. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.

The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email

address, and all multiple entries from the same email address shall be disqualified. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. Online entry webpage computer is the official time keeping device for the Contest. The Station is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties and other technological problems.

- c. The grand prize winner will be required to sign and complete a W9 and must hold a valid form of identification to claim their prize.
- d. Only ONE (1) entry per person is permitted. There will be a total of ONE (1) grand prize winner selected in the Promotion.
- e. All entries must be received by the end of the Entry Period.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Station may change the dates and/or terms of the Promotion without prior notice. Any material changes will be broadcast on the Station and/or posted on its website: [www.1043TheFan.com](http://www.1043TheFan.com). The Promotion is open to legal U.S. residents, 18 years of age and older, residing in one of the Thirteen (13) jurisdictions that makes up the listening areas of the Denver Metropolitan area (Counties include: Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, Jefferson, Gilpin, Weld, Kiowa, Clear Creek, Park and Elbert).   - ii. ONE (1) round of golf for FOUR (4) people, foursome, at one of the five Aurora Golf Courses which include: Aurora Hills Golf Course, Meadow Hills Golf Course, Saddle oack Golf Course, Springhill Golf Course or Murphy Creek Golf Course. Prize is valid for the remainder of the 2020 calendar year. The Approximate Retail Value ("ARV") of the prize is \$200.00.
  - iii. Total Approximate Retail Value ("ARV") of Grand Prize \$5,200.00.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Promotion are final.
- b. Judging of all valid entries received will be conducted at approximately 9:00 AM MT on Friday, June 19, 2020. The Video from each entrant will be judged by a panel of judges from the Station. The video will be judged on the following categories: creativity of video, originality of video and quality of video.
- c. ONE (1) grand prize winner will be selected to receive the following: ONE (1) FIVE THOUSAND DOLLAR \$5,000.00 CREDIT to ProGreen for the installation of artificial turf (Approximate Retail Value ("ARV") \$5,000.00; \$5,000 ProGreen credit must be redeemed by June 19, 2021); and ONE (1) round of golf for FOUR (4) people, foursome, good at any of the five Aurora Golf Courses listed in Section 3(a)(ii) (Approximate Retail Value ("APV") \$200.00).
