Only one (1) entry per eligible Entrant will be allowed, regardless of whether Entrant has more than one email address. Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries will not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Station.
 - d. - e. The prize consists only of the elements expressly set forth above; no other elements or expenses are included in the prize and all such expenses are the sole responsibility of the winner(s). Prizes are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for credit at any time, nor will they be replaced if lost or stolen.
